- Execute/work on projects
 - Organize, review, and analyze case documentation to facilitate effective data access, preparation, and presentation of findings
 - Apply business and accounting acumen, forensic accounting skills, business valuation, and damage calculations for clients often engaged in pre-litigation or litigation
 - o Prepare effective research utilizing industry and market research tools
 - Utilize practice disciplines including, but not limited to: cash flow analysis, financial statement analysis, financial investigations, financial modeling
 - o Create work product that is flexible, understandable, and usable by others
 - Assist with preparation and review of draft written analyses, presentations, quantitative exhibits, expert reports, and other reports for third parties
 - o Understand and utilize project plans to keep knowledgeable and current on project status, budget, timelines, requirements, concerns, etc.
